

Please read the following terms and conditions carefully in relation to your booking. By opening this document, you agree to the terms and conditions

Veposit's

If your wedding booking is during the following months, regarded as Wedding Season (February, March, April, September, October and November) an non refundable deposit of 50% is required within 14 days from the date of issue on the invoice to secure the booking due to high demand. If the booking is in any other month, then a non refundable deposit of \$100 is required within 14 days from the date of issue on the invoice.

The remaining balance is to be paid in full no later than 4 weeks prior to the ceremony date. For all other event bookings, full payment is required within 30 days from the date of issue of the invoice.

Refunds

If you cancel your booking 30 days prior to the event, all payments made (with the exception of the wedding booking fee as above) will be refunded. If you cancel your booking within 30 days of the event, no refund is applicable. If in the extreme event that I have to cancel my services, a full refund will be given, and every attempt will be made to find a replacement celebrant.

Travel Charges

Should the journey is less than 100 km from my home, there will be no extra fee(s) for travel. If the destination is more than 100kms, then an additional travel fee(s) will apply. As per the ATO @ .72c for 2020/2021 will apply per km for any distance 100km's in total. Please contact me to discuss distance from my home address. Weddings & Rehearsal events apply as well. If the distance is significant, then overnight accommodation expenses and other charges would apply unless other arrangements are agreed to between both parties.

Terms & Conditions control

Legal Requirements

For Weddings only ; A Notice of Intended Marriage form must be lodged within the following time frame as per Federal Law. This form can be no earlier than 18 months prior to wedding event, and no later than one month prior to the event. Such as if you wish to marry on the 1st of May, then the form MUST be lodged with the Celebrant no later than the 1st of April. For exceptional circumstances, a court request can occur. Please call me to discuss if this applies.

A charge of 50% deposit fee will apply should the following circumstances arise. The Wedding event is cancelled by yourselves or you wish to transfer your wedding event to another celebrant. The ceremony will not take place if all the required legal documents have not been supplied and sighted, and all relevant documents such as the Notice of Intended Marriage signed and lodged within the legally required time frame.

Social Media Consent

Please advise if you DO NOT give permission to share a picture or two via Instagram and Facebook after your event. I usually refrain for a day or two and sometimes longer. I will assume you have given consent should you not advise either verbally or written, and this only applies to Weddings, Comittment Ceremonies, Renewal of Vows and Naming Days.

Covid 19 restrictions

We all know now that there has been considerable number of restrictions in place for weddings and ceremonies, around the number of people permitted to attend all over Australia. We must comply to the number of guests allowed and all guests will need to check in via my QR code if the event is held anywhere other than a Venue.

Should you have to cancel or postpone your event due to changes such as travel restrictions, lockdowns, health concerns/conditions and diagnosis, you will not forfeit the deposit or any monies paid and I will happily rebook your event date, depending on availability. If the state border(s) is closed and I am unable to attend as a result, I will assist you in finding a suitable replacement celebrant and refund any monies paid. If the new celebrant is happy to deliver my bespoke ceremony I have prepared, we can arrange to have the fee's shared between the celebrants upon agreement

As per our package agreement, I will create a bespoke wedding ceremony that tells your love story. I will send you several forms, and we will do a wedding interview where we can get to know each other.

If rehearsal is included in your package, then we will agree on a suitable date and time for all parties to attend at the venue or agreed location. Not only does this help calm your nerves, but also gives us time to work out logistics. This is when you need to have your bridal team with you. Please let me know if you are using a wedding planner, as we work really well together.

On the day of the ceremony, I will be at the venue no earlier than one hour, and no later than 30 mins to the ceremony commencement time. If you have requested a signing table and chairs from me, this will also be included.

All packages come with my unlimited support, inc sounding board skills when things go a little pear shaped, unlimited email & phone calls and zooms. Co-ordinating a wedding can be stressful, and I promise that I will be there to help and support you both in your journey. I can assist with vow writing, poetry selection and crafting of how you want the day to unfold. I like to know what your colour schemes are too, so I can co-ordinate my outfit as well.

I will play your music selection through my brilliant portable battery operated P.A. system, if you wish. For this to occur, we need to sort that out well before the event. I use Spotify normally.

Inside my Mary Poppins bag, I carry spare wedding rings, just in case someone forgets or there is a hiccup.
